Addressing student safety: Funding for some campuses to create safe spaces, interfaith centers

Campuses reviewed time, place, and manner policies over the summer

As noted before, Chancellor King was asked about the SUNY plan to build a resilient infrastructure, noting that SBU flooding may be a harbinger of things to come. This issue was raised again by the HSC Sector.

Chancellor King responded that he will be making the case for a 5 yr thoughtful SUNY Capital fund. His request will have three goals,

- 1) addressing the maintenance backlog,
- 2) addressing climate resilience, renewable energy, and moving systems out of basements, and
- 3) to meet our ambitious research goal, investments in first-in-class facilities.

He will need our help because the money has to come from beyond SUNY. Our request to the legislature will compete with a request from the MTA, which will be asking for a large amount of money.

- 4) Resolutions
- G&R: "198-01-1 Faculty Freedom and HyFlex Teaching Modality"
  - This resolution advocates for recognition and protection of faculty choice and academic freedom in policies related to the HyFlex teaching modality.
  - For: 38 / Against: 8
- **G&R**: "198-02-1 Graduate Education Standards Workgroup"
  - In order to support high-quality graduate education system-wide, this
    resolution asks for the creation of a SUNY-wide work group charged with
    compiling and sharing best practices for graduate education across the
    SUNY System, as well as sharing research and scholarly professional
    development opportunities.
  - For: 47 / Against: 0
- SL: "198-03-1 Recommendation for the adoption of the Okanagan Charter for Health Promotion in Universities and Colleges"
  - Okanagan Charter for Health Promotion in Universities and Colleges
    provides a comprehensive framework for promoting and enhancing the
    health and well-being of our campus communities and embracing the
    principles outlined in the Okanagan Charter aligns with our campuses
    commitment to fostering a supportive and thriving environment for all
    members of our community. This resolution requests the Chancellor

- recommend adoption and attention to campus policies that align with the Okanagan Charter.
- For: 45 / Against: 2
- EC: "198-05-1 Resolution Endorsing the Joint SUNY UFS, SUNY FCCC, and CUNY UFS Statement on Funding Public Higher Education"
  - This resolution endorses the Joint Statement on funding Public Higher Education. It charges President Landa to advocate with System Administration and state and federal governments for funding on behalf of all public higher education systems in the state.
  - For: 44 / Against: 0
- Floor motion to endorse University at Buffalo Faculty Senate's resolution to change Board of Trustees policy on term appointments
  - A Resolution passed by the University at Buffalo Senate called for a change to Board of Trustees Policy regarding Term Appointments, asking that language specifying terms limited to "not more than three years" be changed to allow "not more than five years."
  - For: 47 / Against 1

## Defeated resolution

- **UG**: "198-04-2 Request to align the 1976 MTP "Credit/Contact Hour Relationship" for applied learning to the regulations set by the NY State Commissioner of Education"
  - A July 1976 MtP regarding applied learning/experiential learning specifies
    that one semester hour of credit will be awarded for 40 45 clock hours of
    supervised activity. This resolution requests updating that MtP to align with
    NYS Commissioner of Education policy that identifies the minimum time
    but no upper limit for awarding one credit hour.
